EXHIBITION TITLE: Bowing to the Figure

EXHIBITION DATES: June 18 – 26, 2020

OPENING RECEPTION: Thursday, June 18, 2020 from 7 pm to 10 pm

OPEN TO: Artists who've attended Harcourt House's Drawing / Sculpture Drop-ins and/or Weekend with the Model sessions in 2019/2020

SUBMISSION Deadline / Artwork Drop-off for Jurying Process: May 4 – 8, 2020 (during drop-in sessions)

Please note: Artwork should not be framed for the Jurying Process.

Pick-up unselected artwork and selected artwork for FRAMING: Friday, May 15, 2020 (during drop-in session)

Drop-off FRAMED artwork: by June 5, 2020 (last drop-in session)

Please note: Wire / saw tooth hanger / keyhole hanger / metal or wood cleat hanger must be installed on a back of the artwork.

EXHIBITION Take-down / artwork pick-up: July 1 and 8, 2020

Harcourt House Artist Run Centre invites all drop-in / Weekend with the Model session participants to submit their work to the Harcourt House Annual Naked Show + Art Sale 2020, that will be open to the public from June 18 – 26, 2020 at Harcourt House's Annex Building / Art Education Room #1.

The artwork selected for this exhibition will be presenting a broad range of conceptual and formalistic approaches to the aspect of human form. Featuring drawings, paintings, and sculpture from Harcourt's Live Model Sessions, the exhibition, "Bowing to the Figure" will allow the viewers to contemplate the beauty of the human body from the perspective of several stylistic directions in the history of art, ranging from Realism, Impressionism, Post-Impressionism through Cubism and Expressionism, to semi-abstract forms.

The Annual Naked Show + Art Sale 2020 allows our artists to exhibit and sell their work while doubling as a fundraiser for Harcourt House in support of its art exhibition and art education programs. If artists choose to sell their work, Harcourt House will receive a 30% commission included in the price of the sale.

Each artist may submit a maximum of five (5) works and is guaranteed to have one work featured in the exhibition, provided they adhere to the submission's criteria (please refer to the Submission Guidelines for details on page #2).

SUBMISSION GUIDELINES:

1. Every artist may submit up to five (5) works for the Exhibition Curators to consider. Every artist who submits will have at least one (1) and up to a maximum of three (3) works in the exhibition.
2. Submitted artwork must be created during the non-instructional Drop-In Drawing, Painting, Sculpture, or “Weekends with the Model” sessions. NO EXCEPTIONS!
3. We will only accept the artwork created within the past year.
4. Late submissions will not be accepted.
5. Artist will provide all information on the **ARTWORK SUBMISSION FORM** and include the form with the submitted artwork. ANY missing information will disqualify the submission from consideration.
6. Drop off the artwork for submission to the **Art Education ROOM #1** in the Harcourt House Annex Building. Do NOT bring the artwork upstairs to the Gallery offices unless it is absolutely necessary.
7. It is the artist’s responsibility to ensure their submissions are clearly labeled for the **Harcourt House Annual Naked Show + Art Sale 2020**. Each artwork you submit **MUST** be labeled – on the back of the artwork itself – with your name and the number on this form that corresponds to the information for the artwork (see page #3).
8. Artwork selected for the Harcourt House Annual Naked Show + Art Sale 2020 will be marked on the submission form with a RED star. These artwork(s) will have to be framed for the exhibition by the artist and returned to the **Art Education ROOM #1** by June 5, 2020.
9. Artist grants permission for Harcourt House Artist Run Centre to reproduce artwork for the promotion and publicity of the exhibition and the drop-in program. Copyright will be attributed to the artist.
10. If artist choose to sell their work, **Harcourt House will receive a 30% commission** included in the price of the sale. The balance of the price of sale for all works sold will be remitted to the artist after the closing of the exhibition.
11. It will be the sole responsibility of the artist and purchaser for the cost of packing and shipping of any artwork sold out to out of town customers.
12. All reasonable care will be taken with submissions. However, Harcourt House Artist Run Centre, its staff and volunteers shall not be held responsible for the loss of and/or damage to artworks.
13. It is the responsibility of the artist to remove the artwork from the **Art Education ROOM #1** on **July 1 and 8, 2020 during drop-in sessions**. Harcourt House Artist Run Centre will NOT assume any responsibility for any artwork remaining on the premises after these dates.
